Summary (as of Apr 10, 2019)

Helping Ensure Life- and Limb-Saving Access to Podiatric Physicians Act or the HELLPP Act

This bill adds podiatrists as covered physicians under the Medicaid program.

Additionally, the bill revises certain documentation requirements related to Medicare coverage of therapeutic shoes for individuals with diabetes.

Finally, the bill subjects payments made to a Medicaid provider or supplier to a continuing levy for federal taxes owed by the provider or supplier.

Actions Timeline

- **Apr 11, 2019:** Referred to the Subcommittee on Health.
- **Apr 10, 2019:** Introduced in House
- **Apr 10, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Apr 10, 2019:** Referred to the Subcommittee on Health.
