Bear Protection Act of 2019

This bill prohibits the import, export, and commerce of bear viscera or related products except for limited acts carried out solely to enforce wildlife protection laws.

Actions Timeline

- **Jun 25, 2020:** Subcommittee Hearings Held.
- **Apr 26, 2019:** Referred to the Subcommittee on Water, Oceans, and Wildlife.
- **Apr 10, 2019:** Introduced in House
- **Apr 10, 2019:** Referred to the Committee on Natural Resources, and in addition to the Committees on Foreign Affairs, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Apr 10, 2019:** Referred to the Subcommittee on Trade.
