## **Medicare Care Coordination Improvement Act of 2019**

This bill exempts certain alternative payment models under Medicare from the general prohibition on physician self-referrals (i.e., the Stark law).

### **Actions Timeline**

- **Apr 11, 2019:** Referred to the Subcommittee on Health.
- **Apr 10, 2019:** Introduced in House
- **Apr 10, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Apr 10, 2019:** Referred to the Subcommittee on Health.
