Summary (as of Jan 3, 2019)

Ban Toxic Pesticides Act of 2019

This bill requires the Environmental Protection Agency (EPA) to cancel the registration of the pesticide chlorpyrifos under the Federal Insecticide, Fungicide, and Rodenticide Act.

The bill prohibits the sale and use of existing stock of chlorpyrifos.

The bill requires the EPA to ban chlorpyrifos residue on food under the Federal Food, Drug, and Cosmetic Act.

Actions Timeline

- **Feb 7, 2019:** Referred to the Subcommittee on Biotechnology, Horticulture, and Research.
- **Jan 25, 2019:** Referred to the Subcommittee on Environment and Climate Change.
- **Jan 3, 2019:** Introduced in House
- **Jan 3, 2019:** Referred to the Committee on Agriculture, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
