Chesapeake Bay Gateways and Watertrails Network Reauthorization Act of 2019

This bill reauthorizes for FY2020-FY2025 the Chesapeake Bay Gateways and Watertrails Network and the Chesapeake Bay Gateways Grants Assistance Program.
