### Summary (as of May 1, 2019)

#### Safe Routes Act of 2019

This bill directs the Department of Transportation to waive vehicle weight limits for covered logging vehicles.

The term "covered logging vehicle" means a vehicle that (1) is transporting raw or unfinished forest products, including logs, pulpwood, biomass, or wood chips; (2) is traveling a distance not greater than 150 air miles from origin to a storage or processing facility; and (3) meets state legal weight tolerances and vehicle configurations for transporting raw or unfinished forest products within the state boundaries in which the vehicle is operating.

- **May 2, 2019:** Referred to the Subcommittee on Highways and Transit.
- **May 1, 2019:** Introduced in House
- **May 1, 2019:** Referred to the House Committee on Transportation and Infrastructure.
