Roadless Area Conservation Act of 2019

This bill bars the Department of Agriculture from allowing the construction of roads, the reconstruction of roads, or logging in an inventoried roadless area where those activities are prohibited by the Roadless Rule (i.e., certain federal regulations relating to roadless area management).

Actions Timeline

- **May 20, 2019:** Referred to the Subcommittee on Conservation and Forestry.
- **May 15, 2019:** Referred to the Subcommittee on National Parks, Forests, and Public Lands.
- **May 2, 2019:** Introduced in House
- **May 2, 2019:** Referred to the Committee on Agriculture, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
