Comprehensive Addiction Resources Emergency Act of 2019

This bill establishes various programs to address substance use disorder and opioid addiction, including grants for treatment, recovery, and harm reduction services as well as a program to distribute overdose reversal drugs.

- **May 13, 2019:** Referred to the Subcommittee for Indigenous Peoples of the United States.
- **May 9, 2019:** Referred to the Subcommittee on Health.
- **May 8, 2019:** Introduced in House
- **May 8, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Natural Resources, and the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
