Resources for Victims of Gun Violence Act of 2019

This bill establishes an Advisory Council to Support Victims of Gun Violence.

Among other things, the advisory council must assess the needs of victims of gun violence and disseminate information about resources available to help victims of gun violence.

Actions Timeline

- **May 31, 2019:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **May 8, 2019:** Introduced in House
- **May 8, 2019:** Referred to the House Committee on the Judiciary.
