Summary (as of Sep 10, 2019)

DHS Overseas Personnel Enhancement Act of 2019

This bill directs the Department of Homeland Security (DHS) to annually brief the congressional homeland security committees regarding DHS personnel with primary duties that take place outside of the United States. DHS must submit to such committees a plan to enhance the effectiveness of DHS personnel at foreign locations.

- **Jun 10, 2019:** Mr. Correa moved to suspend the rules and pass the bill, as amended.
- **Jun 10, 2019:** Considered under suspension of the rules. (consideration: CR H4373-4375)
- **Jun 10, 2019:** DEBATE - The House proceeded with forty minutes of debate on H.R. 2590.
