Summary (as of May 9, 2019)

Preserving Overseas Immigration Services Act

This bill prohibits the Department of Homeland Security from closing or consolidating any field office of the International Operations Division of the Refugee, Asylum, and International Operations Directorate of U.S. Citizenship and Immigration Services unless it obtains the approval of specified congressional committees.

Actions Timeline

- **Jun 26, 2019:** Referred to the Subcommittee on Immigration and Citizenship.
- **May 9, 2019:** Introduced in House
- **May 9, 2019:** Referred to the Committee on Homeland Security, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
