## **Breast Cancer Research Stamp Reauthorization Act of 2019**

This bill reauthorizes through December 31, 2027, provisions requiring the U.S. Postal Service to issue a special postage stamp for first-class mail that costs more than the regular first-class stamp to raise funds for breast cancer research.

- **May 15, 2019:** Referred to the Subcommittee on Military Personnel.
- **May 15, 2019:** Referred to the Subcommittee on Health.
- **May 14, 2019:** Introduced in House
- **May 14, 2019:** Referred to the Committee on Oversight and Reform, and in addition to the Committees on Energy and Commerce, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
