Summary (as of May 22, 2019)

Filipino Veterans Family Reunification Act of 2019

This bill exempts from worldwide or numerical limitations certain family-sponsored immigrant visas for the sons and daughters of Filipino World War II veterans who were naturalized under certain laws providing for naturalization for service during World War II.
