Summary (as of Jul 9, 2019)

Improving Investment Research for Small and Emerging Issuers Act

This bill requires the Securities and Exchange Commission to report on investment research regarding small issuers, including emerging growth companies and companies considering initial public offerings. The report must (1) include topics such as the availability of such research and potential conflicts of interest relating to its production and distribution, and (2) make recommendations for increasing small-issuer investment research.

Actions Timeline

- **Jul 10, 2019:** Received in the Senate and Read twice and referred to the Committee on Banking, Housing, and Urban Affairs.
- **Jul 9, 2019:** Ms. Waters moved to suspend the rules and pass the bill.
- **Jul 9, 2019:** Considered under suspension of the rules. (consideration: CR H5283)
- **Jul 9, 2019:** DEBATE - The House proceeded with forty minutes of debate on H.R. 2919.
- **Jul 9, 2019:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote.(text: CR H5283)
