Summary (as of May 23, 2019)

Parren Mitchell Minority Business Education and Empowerment Act of 2019

This bill requires the Small Business Administration to award grants through FY2022 to historically black colleges and universities to (1) establish entrepreneurship curricula for undergraduate or graduate studies, and (2) place small business development centers on the physical campuses of such institutions.

Actions Timeline

- **Oct 2, 2020:** ASSUMING FIRST SPONSORSHIP - Mr. Mfume asked unanimous consent that he may hereafter be considered as the first sponsor of H.R. 2981, a bill originally introduced by Representative Cummings, for the purpose of adding cosponsors and requesting reprintings pursuant to clause 7 of rule XII. Agreed to without objection.
- **May 23, 2019:** Introduced in House
- **May 23, 2019:** Referred to the Committee on Education and Labor, and in addition to the Committee on Small Business, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
