## Summary (as of May 30, 2019)

This bill extends the Secure Rural Schools and Community Self-Determination Act of 2000 through FY2020, including provisions concerning secure payments to eligible states, territories, and counties containing federal land.

## Actions Timeline

- **Jun 21, 2019:** Referred to the Subcommittee on Conservation and Forestry.
- **Jun 14, 2019:** Referred to the Subcommittee on National Parks, Forests, and Public Lands.
- **May 30, 2019:** Introduced in House
- **May 30, 2019:** Referred to the Committee on Agriculture, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
