Summary (as of Jun 12, 2019)

Access to Genetic Counselor Services Act of 2019

This bill provides for coverage under Medicare of genetic counseling services that are furnished by genetic counselors. Covered services include those services, as well as incidental services and supplies, that would otherwise be covered under Medicare if provided by a physician.

Actions Timeline

- **Jun 13, 2019:** Referred to the Subcommittee on Health.
- **Jun 12, 2019:** Introduced in House
- **Jun 12, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
