Summary (as of Jun 27, 2019)

Laboratory Access for Beneficiaries Act or the LAB Act

This bill revises the periods during which laboratories must report clinical diagnostic test information to the Centers for Medicare & Medicaid Services (CMS) for purposes of determining Medicare payment rates. The CMS must also contract with the National Academies of Sciences, Engineering, and Medicine to evaluate the methodology used to determine a specified laboratory fee schedule.

Actions Timeline

- **Jun 28, 2019:** Referred to the Subcommittee on Health.
- **Jun 27, 2019:** Introduced in House
- **Jun 27, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
