Summary (as of Jul 9, 2019)

Livestock Protection Act of 2019

This bill authorizes the U.S. Fish and Wildlife Service to issue a permit to a livestock farmer for the taking of black vultures during the calving or lambing season if it protects livestock from damage or loss.

A permit holder must annually report to the state enforcement agency each taking of a black vulture.

Actions Timeline

- **Jul 24, 2019:** Referred to the Subcommittee on Water, Oceans, and Wildlife.
- **Jul 9, 2019:** Introduced in House
- **Jul 9, 2019:** Referred to the House Committee on Natural Resources.
