EAGLES Act of 2019

This bill reauthorizes the National Threat Assessment Center (NTAC) within the U.S. Secret Service.

It reauthorizes the functions of NTAC through FY2023 and expands them to include the establishment of a national program on targeted school violence prevention.

Actions Timeline

- **Aug 6, 2019:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Jul 11, 2019:** Introduced in House
- **Jul 11, 2019:** Referred to the Committee on the Judiciary, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
