## Summary (as of Jul 16, 2019)

### Cady Housh and Gemesha Thomas Student Suicide Prevention Act of 2019

This bill reauthorizes through FY2025, and otherwise revises, grants administered by the Substance Abuse and Mental Health Services Administration (SAMHSA) to support youth suicide early-intervention and prevention strategies. Specifically, the bill requires SAMHSA to award a portion of such grants for statewide training programs on emotional well-being, mental health, and suicide awareness and prevention for elementary and secondary school students and staff.

## Actions Timeline

- **Jul 17, 2019:** Referred to the Subcommittee on Health.
- **Jul 16, 2019:** Introduced in House
- **Jul 16, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
