## Summary (as of Jul 23, 2019)

### Protection of American Jobs in Cross-Border Rail Operations With Mexico Act

This bill requires the Department of Transportation to issue regulations that restrict the operation of trains originating in Mexico within the United States to crews comprised entirely of U.S. citizens and nationals.
