Greater Access and Independence through Nonvisual Access Technology Act of 2019 or the GAIN Act

This bill requires the Architectural and Transportation Barriers Compliance Board (Access Board) to establish access standards for home (1) medical devices, (2) appliances, and (3) exercise equipment that allow blind consumers to effectively use such products.

Actions Timeline

- **Jul 25, 2019:** Referred to the Subcommittee on Consumer Protection and Commerce.

- **Jul 24, 2019:** Referred to the House Committee on Energy and Commerce.
