EARLY Act Reauthorization of 2020

This bill reauthorizes through FY2025 programs that raise public awareness about breast health, educate health care providers to encourage early detection of breast cancer, and provide support for young women diagnosed with breast cancer.

Actions Timeline

- **Sep 30, 2020:** Received in the Senate and Read twice and referred to the Committee on Health, Education, Labor, and Pensions.
- **Sep 29, 2020:** Mr. Pallone moved to suspend the rules and pass the bill, as amended.
- **Sep 29, 2020:** Considered under suspension of the rules. (consideration: CR H4999-5000)
- **Sep 29, 2020:** DEBATE - The House proceeded with forty minutes of debate on H.R. 4078.
- **Sep 29, 2020:** Passed/agreed to in House: On motion to suspend the rules and pass the bill, as amended Agreed to by voice vote.
