## **Coronavirus Housing Counseling Improvement Act**

This bill authorizes additional housing counseling services, provided through the Neighborhood Reinvestment Corporation, with priority for funding given to counseling organizations that target and provide their services to low-income and minority homeowners, renters, individuals experiencing homelessness, and individuals at risk of homelessness.
