Summary (as of Sep 10, 2019)

Act for the Amazon Act

This bill requires the President to prohibit the importation of certain products from Brazil, restricts the President from providing military or security assistance to Brazil, and prohibits any negotiations by a federal department or agency to enter into a free trade agreement with Brazil.

Actions Timeline

- **Sep 10, 2019:** Introduced in House
- **Sep 10, 2019:** Referred to the Committee on Foreign Affairs, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Sep 10, 2019:** Referred to the Subcommittee on Trade.
