## Summary (as of Sep 11, 2019)

### Broadband Interagency Coordination Act of 2019

This bill requires the Federal Communications Commission, the National Telecommunications and Information Administration, and the Department of Agriculture to enter into an interagency agreement to coordinate the distribution of federal funds for new broadband deployment.

### Actions Timeline

- **Sep 24, 2019:** Referred to the Subcommittee on Commodity Exchanges, Energy, and Credit.
- **Sep 18, 2019:** Sponsor introductory remarks on measure. (CR H7758)
- **Sep 12, 2019:** Referred to the Subcommittee on Communications and Technology.
- **Sep 11, 2019:** Introduced in House
- **Sep 11, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
