### Summary (as of Sep 12, 2019)

#### Safe Cosmetics and Personal Care Products Act of 2019

This bill expands the Food and Drug Administration's authority to regulate cosmetics, including with respect to safety standards, product recalls, and product testing. The bill also generally prohibits the use of animal testing for the purpose of developing cosmetics.

## Actions Timeline

- **Sep 13, 2019:** Referred to the Subcommittee on Health.
- **Sep 12, 2019:** Introduced in House
- **Sep 12, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
