National Gun Violence Research Act

This bill amends various provisions of law and sets forth new provisions to promote gun violence research.

Among other things, the bill does the following:

- removes limitations on the use of firearms tracing data by the Bureau of Alcohol, Tobacco, Firearms and Explosives;
- permits funds made available to the Department of Health and Human Services to be used for gun violence research;
- establishes the National Gun Violence Research Program to promote gun violence research; and
- authorizes various competitive grants to support research into the nature, causes, consequences, and prevention of gun violence.

Actions Timeline

- **Feb 12, 2019:** Referred to the Subcommittee on Research and Technology.
- **Jan 25, 2019:** Referred to the Subcommittee on Health.
- **Jan 10, 2019:** Introduced in House
- **Jan 10, 2019:** Referred to the Committee on the Judiciary, and in addition to the Committees on Science, Space, and Technology, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jan 10, 2019:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
