## Summary (as of Mar 2, 2020)

### Yes In My Backyard Act

This bill requires certain Community Development Block Grant program recipients to submit to the Department of Housing and Urban Development information regarding their implementation of certain land-use policies (e.g., policies for reducing minimum lot size).
