This resolution sets forth the rule for consideration of H.R. 3055 (Commerce, Justice, Science, Agriculture, Rural Development, Food and Drug Administration, Interior, Environment, Military Construction, Veterans Affairs, Transportation, and Housing and Urban Development Appropriations Act, 2020) and H.R. 2740 (Departments of Labor, Health and Human Services, and Education, and Related Agencies Appropriations Act, 2020).

Certain proceedings may take place on any legislative day from June 28, 2019, through July 8, 2019.

It shall be in order (1) to consider concurrent resolutions providing for adjournment during July 2019, and (2) at any time on the legislative day of June 27, 2019, for the Speaker of the House to suspend the rules.

### Actions Timeline

- **Jun 19, 2019:** The House Committee on Rules reported an original measure, H. Rept. 116-119, by Mr. McGovern.
- **Jun 19, 2019:** Rule provides for consideration of H.R. 3055 under a structured rule. Rule also provides for proceedings during the period from June 28, 2019, through July 9, 2019. Rule also provides that it shall be in order on the legislative day of June 27, 2019, that the House suspend the rules.
- **Jun 19, 2019:** Placed on the House Calendar, Calendar No. 30.
- **Jun 19, 2019:** Considered as privileged matter. (consideration: CR H4779-4787)
- **Jun 19, 2019:** DEBATE - The House proceeded with one hour of debate on H. Res. 445.
- **Jun 19, 2019:** UNANIMOUS CONSENT REQUEST - Mr. McGovern asked unanimous consent that the amendment at the desk be considered as though printed as amendment No. 123 in Part B of House Report 116-119, if offered by Mrs. Lee (NV) or her designee, be debatable for 10 minutes equally divided and controlled by the proponent and an opponent. The Clerk reported the amendment. Mr. Woodall objected to the unanimous consent request. Subsequently, the objection was withdrawn. Agreed to without objection.
- **Jun 19, 2019:** DEBATE - The House resumed with debate on H. Res. 445.
- **Jun 19, 2019:** POSTPONED PROCEEDING - At the conclusion of debate on H.Res. 445, the Chair put the question on ordering the previous question and by voice vote announced that the yeas had prevailed. Mr. Woodall demanded the yeas and nays on ordering the previous question and the Chair postponed further proceedings until later in the legislative day.
- **Jun 19, 2019:** Considered as unfinished business. (consideration: CR H4787-4789)
- **Jun 19, 2019:** On ordering the previous question Agreed to by the Yeas and Nays: 232 - 193 (Roll no. 356). (consideration: CR H4787-4788)
- **Jun 19, 2019:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 231 - 195 (Roll no. 357).(text: CR H4779-4780)
- **Jun 19, 2019:** On agreeing to the resolution Agreed to by the Yeas and Nays: 231 - 195 (Roll no. 357). (text: CR H4779-4780)
- **Jun 19, 2019:** Motion to reconsider laid on the table Agreed to without objection.
