## Summary (as of Dec 8, 2020)

### Veteran Benefits Enhancement and Expansion Act of 2020

This bill modifies provisions related to the Servicemembers Civil Relief Act and various Department of Veterans Affairs programs and benefits for veterans, including those related to education benefits, burial benefits, the home loan program, service-connected disability matters, and representation and financial exploitation matters.
