Safe at Home Act

This bill requires each executive agency and federal court to accept, for any purpose for which an individual is required to provide an address to the agency or court, an address designated to that individual pursuant to an address confidentiality program (e.g., a program to protect stalking or domestic violence victims).

Actions Timeline

- **Nov 15, 2019:** Referred to the Subcommittee on Courts, Intellectual Property, and the Internet.
- **Oct 16, 2019:** Introduced in House
- **Oct 16, 2019:** Referred to the Committee on Oversight and Reform, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
