## Summary (as of Oct 17, 2019)

This bill generally addresses the response of federal agencies to climate change, including by providing for the admission to the United States of climate displaced persons, by requiring the Department of State to develop a Global Climate Change Resilience Strategy, and by requiring the Government Accountability Office to report on the progress made towards incorporating climate change into the policy of departments and agencies.

## Actions Timeline

- **Nov 15, 2019:** Referred to the Subcommittee on Immigration and Citizenship.
- **Oct 18, 2019:** Referred to the Subcommittee on Environment and Climate Change.
- **Oct 17, 2019:** Introduced in House
- **Oct 17, 2019:** Referred to the Committee on Foreign Affairs, and in addition to the Committees on the Judiciary, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
