Summary (as of Oct 18, 2019)

Honest Elections Act

This bill modifies registration requirements for foreign agents who engage in political activities, requires that certain disclosures be made in online political communications, and prohibits a state from receiving certain election assistance funds if the state allows ballot harvesting or voting by noncitizens.

Actions Timeline

- **Oct 23, 2019:** Sponsor introductory remarks on measure. (CR H8411-8412)
- **Oct 18, 2019:** Introduced in House
- **Oct 18, 2019:** Referred to the Committee on House Administration, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
