Summary (as of Oct 28, 2019)

Real Marketing Edible Artificials Truthfully Act of 2019 or the Real MEAT Act of 2019

This bill prohibits the sale of any imitation meat food product unless its label includes (1) the word *imitation*, and (2) a statement that clearly indicates the product is not derived from or does not contain meat.

Actions Timeline

- **Nov 14, 2019:** Referred to the Subcommittee on Livestock and Foreign Agriculture.
- **Oct 29, 2019:** Referred to the Subcommittee on Health.
- **Oct 28, 2019:** Introduced in House
- **Oct 28, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
