Summary (as of Oct 28, 2019)

Veteran Deportation Prevention and Reform Act

This bill modifies immigration and naturalization procedures for noncitizens who are members or veterans of the Armed Forces. Specifically, the bill requires interagency coordination to (1) identify such individuals who are the subject of immigration removal proceedings or who have already been removed; and (2) naturalize them as citizens or otherwise change their status, as appropriate.

Actions Timeline

- **Dec 18, 2019:** Referred to the Subcommittee on Immigration and Citizenship.
- **Nov 8, 2019:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
- **Oct 28, 2019:** Introduced in House
- **Oct 28, 2019:** Referred to the Committee on the Judiciary, and in addition to the Committees on Veterans' Affairs, and Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
