## Summary (as of Nov 14, 2019)

---

This bill revokes certain waivers of sanctions for nuclear activity in or with Iran, including for (1) the Arak reactor redesign, (2) the transfer into Iran of enriched uranium for the Tehran Research Reactor, and (3) the modification of centrifuge cascades at the Fordow facility.

## Actions Timeline

---

- **Dec 18, 2019:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Nov 14, 2019:** Introduced in House
- **Nov 14, 2019:** Referred to the Committee on Foreign Affairs, and in addition to the Committees on Financial Services, the Judiciary, and Oversight and Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
