Providing for consideration of the bill (H.R. 397) to amend the Internal Revenue Code of 1986 to create a Pension Rehabilitation Trust Fund, to establish a Pension Rehabilitation Administration within the Department of the Treasury to make loans to multiemployer defined benefit plans, and for other purposes; providing for consideration of the bill (H.R. 3239) to require U.S. Customs and Border Protection to perform an initial health screening on detainees, and for other purposes; providing for proceedings during the period from July 29, 2019, through September 6, 2019; and for other purposes.

This resolution sets forth the rule for consideration of H.R. 397 (Rehabilitation for Multiemployer Pensions Act), H.R. 3239 (Humanitarian Standards for Individuals in Customs and Border Protection Custody Act), and adopts H.Res. 507 (ratifies and affirms current and future House investigations and subpoenas related to the President).

It shall be in order at any time on the legislative day of July 25, 2019, or July 26, 2019, for the Speaker of the House to suspend the rules.

Certain proceedings may take place on any legislative day from July 29, 2019, through September 6, 2019.

- **Jul 24, 2019:** Considered as privileged matter. (consideration: CR H7257-7263)
- **Jul 24, 2019:** DEBATE - The House proceeded with one hour of debate on H. Res. 509.
- **Jul 24, 2019:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 509, the Chair put the question on ordering the previous question and by voice vote, announced the ayes had prevailed. Mr. Burgess demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.

Resolution also provides that it shall be in order on the legislative day of July 25, 2019 or July 26, 2019 that the House suspend the rules. Resolution additionally provides for proceedings from the period from July 29, 2019 through September 6, 2019.
