Summary (as of Nov 15, 2019)

Rebuilding Our Communities by Keeping aggregates Sustainable Act or the ROCKS Act

This bill directs the Department of Transportation to establish a working group of federal, state, tribal, and local stakeholders to conduct a study on the regulatory and legislative improvements necessary to preserve access to covered resources and reduce the costs and environmental impacts of infrastructure projects. (*Covered resources* are materials used in the construction and maintenance of roads, buildings, and other facilities, including stone, sand, and gravel.)

- **Nov 15, 2019:** Introduced in House
- **Nov 15, 2019:** Referred to the House Committee on Transportation and Infrastructure.
