Summary (as of Dec 18, 2020)

This concurrent resolution directs the Secretary of the Senate to make corrections in the enrollment of S. 3312 (Crisis Stabilization and Community Reentry Act of 2020), which authorizes the Department of Justice to award grants to provide clinical services for individuals with serious mental illness and substance use disorders who need post-release mental health services. The resolution expands the entities that are eligible for grants to include Indian tribes, units of local government, and community-based nonprofit organizations.
