## Summary (as of Nov 21, 2019)

### Quality Care for Nursing Home Residents Act of 2019

This bill establishes several requirements for Medicare skilled nursing facilities and Medicaid nursing facilities with respect to minimum staffing levels, training for nurses, and protections for whistleblowers and residents. The bill also requires specific consent procedures in relation to the administration of certain psychotropic drugs and prohibits the use of pre-dispute arbitration agreements in such facilities.

## Actions Timeline

- Nov 22, 2019: Referred to the Subcommittee on Health.
- Nov 21, 2019: Introduced in House
- Nov 21, 2019: Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
