### End Price Gouging for Insulin Act

This bill requires the Department of Health and Human Services to set a maximum price for insulin products for individuals and enrollees of federal health programs.

## Actions Timeline

- **Jan 14, 2020:** Referred to the Subcommittee on Health.
- **Dec 18, 2019:** Referred to the Subcommittee for Indigenous Peoples of the United States.
- **Dec 10, 2019:** Referred to the Subcommittee on Health.
- **Dec 9, 2019:** Introduced in House
- **Dec 9, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Armed Services, Veterans' Affairs, Oversight and Reform, and Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
