Summary (as of Dec 3, 2019)

This resolution calls on all leaders of the Group of Seven (a group consisting of the seven largest major advanced economies, as determined by the International Monetary Fund) to oppose Russia's readmission into the group. The resolution also condemns Russia's assaults on democratic societies worldwide and its aggressive actions in Ukraine.

(Russia was disinvited from the Group of Eight in 2014 after it occupied parts of Ukraine, including the Crimea region.)

Actions Timeline

- **Dec 3, 2019:** Mr. Sires moved to suspend the rules and agree to the resolution.
- **Dec 3, 2019:** Considered under suspension of the rules. (consideration: CR H9197-9198)
- **Dec 3, 2019:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 546.
- **Dec 3, 2019:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
