Summary (as of Dec 9, 2020)

Ceiling Fan Improvement Act of 2020

This bill revises the energy conservation standard for ceiling fans. Specifically, it sets forth energy efficiency standards for electricity used by large-diameter ceiling fans manufactured on or after January 21, 2020. It also exempts such fans from certain requirements under the rule titled *Energy Conservation Program: Energy Conservation Standards for Ceiling Fans*.
