Electric Vehicle Freedom Act or the EV Freedom Act

This bill establishes a national network of publicly available electric vehicle charging stations along public roads and the National Highway System in the United States.

Actions Timeline

- **Feb 6, 2020:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
