Trillion Trees Act

This bills establishes requirements and incentives to plant trees and conduct other land management practices for the purposes of capturing and storing carbon.

Actions Timeline

- **Feb 26, 2020:** Committee Hearings Held.
- **Feb 25, 2020:** Referred to the Subcommittee on Conservation and Forestry.
- **Feb 12, 2020:** Introduced in House
- **Feb 12, 2020:** Referred to the Committee on Agriculture, and in addition to the Committees on Foreign Affairs, Natural Resources, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
