## Summary (as of Feb 13, 2020)

### Federal Employee Parental Leave Technical Correction Act

This bill expands certain paid parental leave benefits to include specified public sector employees, including employees of the Federal Aviation Administration and the Transportation Security Administration, the Executive Office of the President and the White House, and the District of Columbia Courts and Public Defender Service.

## Actions Timeline

- **Mar 10, 2020:** Referred to the Subcommittee on Courts, Intellectual Property, and the Internet.
- **Mar 2, 2020:** Referred to the Subcommittee on Health.
- **Feb 13, 2020:** Introduced in House
- **Feb 13, 2020:** Referred to the Committee on Oversight and Reform, and in addition to the Committees on House Administration, Veterans' Affairs, and the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
