## Summary (as of Feb 25, 2020)

### Hemophilia SNF Access Act

This bill includes certain treatments for hemophilia and other bleeding disorders as high-cost, low-probability ancillary services that may be paid for separately, rather than under the prospective payment (i.e., per diem) system for skilled nursing facilities, under Medicare.

### Actions Timeline

- **Feb 25, 2020:** Introduced in House
- **Feb 25, 2020:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Feb 25, 2020:** Referred to the Subcommittee on Health.
