## **Supporting Survivors of Military Sexual Trauma Act of 2020**

This bill directs the Department of Defense (DOD) and the Department of Veterans Affairs (VA) to develop, implement, and maintain a standard of coordinated care for members of the Armed Forces who are survivors of sexual trauma, including by requiring that information is posted in DOD facilities regarding VA services for such survivors.

### **Actions Timeline**

- **Jun 16, 2020:** Referred to the Subcommittee on Health.
- **Mar 5, 2020:** Introduced in House
- **Mar 5, 2020:** Referred to the Committee on Armed Services, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
